SRTC seeks public input on an amendment to the transportation program

The Spokane Regional Transportation Council (SRTC) is asking community members to provide input on a July Amendment to the <u>2025-2028 Transportation Improvement Program</u> (TIP). The TIP is a comprehensive four-year program containing regionally significant transportation projects and funding allocations.

The proposed amendment would add one new project from the City of Spokane Valley. The South Barker Roadway Corridor project is going to reconstruct a quarter-mile section of the corridor between Interstate 90 and East Appleway Avenue as an urban section, including additional through lanes and sidewalks.

What is the TIP?

The TIP contains a wide variety of transportation projects in Spokane County. Some examples include projects that maintain existing roads, public transit investments and bridge repairs. The document includes project details, jurisdictions sponsoring them, funding attached to each project and where the funding came from (local, state or federal dollars).

The TIP is amended monthly throughout most of the year. Agencies submit amendments to SRTC, which includes projects to add, change or remove from the TIP.
