



SRTC seeks public input on an amendment to the transportation program

FOR IMMEDIATE RELEASE: August 11, 2025 | Spokane County, WA

The Spokane Regional Transportation Council (SRTC) is asking community members to provide input on a September Amendment to the [2025-2028 Transportation Improvement Program](#) (TIP). The TIP is a comprehensive four-year program containing regionally significant transportation projects and funding allocations.

The proposed amendment would amend three existing projects and add four new ones. Notably, the Spokane International Airport received a \$22.8 million award from a Federal grant program to significantly further the construction of a grade-separated interchange at Airport Drive and to realign Spotted Road so that it is outside of the Runway Protection Zone.

What is the TIP?

The TIP contains a wide variety of transportation projects in Spokane County. Some examples include projects that maintain existing roads, public transit investments and bridge repairs. The document includes project details, jurisdictions sponsoring them, funding attached to each project and where the funding came from (local, state or federal dollars).

The TIP is amended monthly throughout most of the year. Agencies submit amendments to SRTC, which includes projects to add, change or remove from the TIP.
