



SRTC seeks public input on an amendment to the transportation program

FOR IMMEDIATE RELEASE: December 08, 2025 | Spokane County, WA

The Spokane Regional Transportation Council (SRTC) is asking community members to provide input on a January 2026 Amendment to the [2026-2029 Transportation Improvement Program](#) (TIP). The TIP is a comprehensive four-year program containing regionally significant transportation projects and funding allocations.

The proposed amendment would amend 14 existing projects and add four new ones. This amendment is larger than normal due to SRTC's recent [Call for Projects](#), which awarded approximately \$40 million of federal funds to transportation projects across the region. Additionally, some projects are being removed from the TIP because agencies have been approved to spend the funds, a process called obligation.

What is the TIP?

The TIP contains a wide variety of transportation projects in Spokane County. The document includes project details, jurisdictions sponsoring them, funding attached to each project and where the funding came from (local, state or federal dollars).

The TIP is amended monthly throughout most of the year. Agencies submit amendments to SRTC, which includes projects to add, change or remove from the TIP.
